The CRP® exam will be offered at hundreds of designated testing centers worldwide AND via live, online proctoring, from Tuesday 16 May 2023 – Friday 9 June 2023 (the specific site, date, and time will be chosen by each registered candidate closer to the exam start date).

- On or before 3 March 2023: \$350 application fee,
- Between 4 March and 14 April 2023: \$475 application fee
- On/after 15 April 2023: \$575 application fee
